In those days, Kenya's space for freedom of expression was not very open and there were no clear mechanisms by which the public could hold the government accountable.

With taxpayers getting disillusioned and frustrated in their attempts to access better services, a natural progression took place where individual associations realized it was more expedient and effective to act through one federated organization that represent the views of all members. Nine Associations explored and pioneered the formation of KARA in 1999 and the Alliance was subsequently registered in the year 2000.

Over the last one and a half decades, our country has undergone tremendous transformation for the better and Kara has steadily championed and facilitated access to better services across the Country. With the democratic space opening up and citizens becoming more and more interested in government transparency and accountability, residents associations have emerged as effective mechanism of engaging with the Government in service delivery issues.

With the new governance dispensation that emphasizes public participation in every aspect of governance, the place and role of residents associations cannot be overemphasized. We are grateful that today the Government recognizes and is keen to engage Residents Associations in decision making processes.

As we mark our 15<sup>th</sup> Anniversary, we are alive to the fact that the coming years are going to be even more challenging and demanding for Kara. But we are confident that the impact of Kara and its members will be much greater. We are also cognizant of the fact that ICT has revolutionized the way of doing business in the world generally and Kenya in particular. Residents associations must therefore embrace the use of ICT in driving their agendas if they are to remain effective and of value to their members.

We are pleased that already some of our members are using applications that are aimed at enhancing communication and revenue collection from their members. We hope that the same can be replicated in other associations across the country.

We are equally keen to understand the mechanisms the government has put in place to ensure proper use of technology in enhancing service delivery efficiency and effectiveness. It is for this reason that we requested our chief guest, Dr. Fred Matiangi, the Cabinet Secretary for Information, Communications and Technology, our chief guest today, to join us for the luncheon and share with us information on the achievements made by the Government in regard to the use of ICT in service delivery. And on behalf of KARA, I would like to thank him for sparing time from his busy schedule to join us at this function.
